By way of the present petition, the Petitioner- Oxfam India challenges the impugned order dated 1st December, 2022 passed by the MHA refusing to renew the license of the Petitioner under the Foreign Contribution (Regulation) Act, 2010. By the said impugned order, the revision application dated 13th January, 2022 filed by the Petitioner under section 32 of the FCRA 2010 challenging the non-renewal of the FCRA registration vide order dated 7th December, 2021, has been dismissed.

8. Mr. Ramesh Singh, ld. Sr. Counsel submits that the Petitioner ought to be permitted to use the amount of Rs.21.39 crore which was received by it at the time when FCRA registration was valid, so that the same could be utilised for its social welfare activities.
