#### ORDER

The Writ Petition has been filed mainly complaining about the noise pollution due to the construction activities undertaken by R1 and R2. Petitioner seeks for an interim order directing the respondents to desist from undertaking noise making construction activities during the night hours in the vicinity of the Vizhinjam Project area till the disposal of the Writ Petition.

2. Heard the learned senior counsel appearing for R1 as well as the learned counsel appearing for R2 and the learned Government Pleader.

3. The learned senior counsel appearing for R1 upon instructions and on the basis of the counter affidavit submitted that they are not undertaking any activities in violation of the sound limit fixed as per the schedule attached to the Noise Pollution (Regulation & Control) Rules, 2000.

4. The learned counsel appearing for R2 would submits that the issues have been considered by the National Green Tribunal and an order has been issued and a monitory agency

has been appointed so as to monitor all the activities including issue of noise pollution. Learned senior counsel for R1 on the basis of Ext.R1(c) submitted that impact due to Port Construction Activities is being monitored and on the basis of Clause:5.7.1.1 of Ext.R1(c) submitted that during the study period noise level were in the range of 38 to 50.1 dB(A) (Leq) during day time and between 39.4 to 51.1 dB(A) Leg during night time, which is below the IFC-EHS General guidelines noise standard of 55 dB(A) Leq during day time and 45 dB(A) during night time. The respondents shall produce a copy of the order passed by National Green Tribunal whereby a monitory agency the has been appointed and also a copy of the IFC-EHS General guidelines regarding the noise standard for the perusal of this court. The submission of the respondents 1 and 2 that they shall maintain the sound limit fixed as per the schedule attached to the Noise Pollution (Regulation & Control) Rules, 2000 is recorded.
