**UPON hearing the counsel the Court made the following
O R D E R**

- 1 The Committee chaired by Mr Justice Deepak Gupta, Former Judge of this Court is in the process of carrying out its task.
- 2 On the request of Mr S Prabhakaran, Senior Counsel appearing on behalf of the Bar Council of India, list the Writ Petitions and the Transferred Cases on 15 December 2023.

IA No 182251 of 2023 in Writ Petition (C) No 82 of 2023

- 4 Learned counsel for the applicant draws the attention of the Court to the relief sought in Clause V of paragraph 20 of the Petition under Article 32 of the Constitution which is in the following terms :

“(V) ISSUE a writ of mandamus inter alia directing the Respondents to not to extend the terms of the Bar Council of States beyond the period of five years.”

- 5 The Court has been apprised of the fact that subsequently, action for extending

the term of different State Bar Councils by a period of five years has been taken.

- 6 The petitioner or any other person aggrieved is at liberty to pursue the appropriate remedies in accordance with law to challenge the action.
- 7 Hence the IA is not entertained at this stage and is accordingly disposed with the above liberty.

Writ Petition (C) No 776 of 2016

- 8 The counsel appearing on behalf of the petitioner(s) seeks the permission of the Court to withdraw the Writ Petition as the same has become infructuous.
- 9 The Writ Petition is dismissed as having become infructuous.
