Issue a writ of mandamus or any other appropriate writs, directions or orders directing the respondents to issue hard copy of driving licence/registration certificate to all those who are eligible to get them and who are not being issued with, within a time limit to be fixed by this Honourable Court.”

2. Today when the matter is called out, the learned Senior Government Pleader made available a communication dated 06.04.2024 issued by the Transport Commissioner, Motor Vehicles Department, by which it has been clarified that the printing work has resumed from 01.04.2024 and Registration Certificates as well as Driving Licences, which are printed, are being dispatched on the same day. Hence, the writ petition is closed.
