Subject: Regarding taking suo moto cognisance w.r.t. breach of Prime Minister's protocol and serious security lapse on the part of State Government.

Lordship,

Being the Chairman of Bar Council, I most humbly seek your kind indulgence for taking cognisance of the major security lapse w.r.t. a high threat perception individual/SPG's blue book protectee, due to the sketchy approach of the Government of Punjab.

Punjab Government's effort was nothing short of cynical connivance with farmers' supported unions, when the PM's convoy was blocked at the flyover near village Piareana in the Ghall Khurd tehsil of Ferozepur district while enroute to National Martyrs' Memorial at Ferozepur's Hussainiwala village on the border with Pakistan. The PM was left totally exposed atop an unsecured flyover for over 15-20 mins i.e. only kms away from the India-Pakistan Border.

As reported, inspite of being communicated well in advance, the Punjab government failed to make necessary arrangements for logistics, security as well as keep a contingency plan ready as is routinely done. Now, a high-level committee under HMJ. MS Gill (Retd.) has been constituted by the Punjab Government which may give its report within three days.
