**ORDER**

The learned counsels appearing for the petitioners pressed for an interim order. I have carefully perused the same, and prima facie, I do not find any reasons to interfere with the nominations made by the 1<sup>st</sup> respondent, by way of an interim order. It is seen from the records that all the persons nominated were included in the panel of candidates forwarded by the Vice Chancellor of the University. In such circumstances, I do not find any necessity to pass an interim order in this case.
