ORDER

1. This writ petition arises out of the peculiar facts.

2. In the counselling, the petitioner was alloted the college, where the course did not exist. As such, the petitioner was required to approach this Court.

3. We have requested Ms. Aishwarya Bhati, learned Additional Solicitor General to take instructions whether any vacant seat is available, so that the petitioner can be accommodated on such a seat.

4. The learned Additional Solicitor General, has graciously stated that though such a seat is available at Government Kilpauk Medical College (M.CH. Neuro Surgery) since the candidate selected for the said seat, did not join the course. She, however, submits that since the cut-off date is already over, it will not be possible for the college to admit the petitioner.

5. Taking into consideration the above facts, we find that the petitioner cannot be penalized for no fault of his. In the the peculiar facts and circumstances and treating the present petition as an exceptional case, the petitioner is directed to be admitted in Government Kilpauk Medical College (M.CH. Neuro Surgery).

6. Needless to State that the petitioner would be entitled to refund of all the amounts deposited by him with the
