## ORDER

- 1. Applications for impleadment/intervention are allowed.
- 2. Leave granted.
- This Civil Appeal is by the Medical Council of India 3. against the decision of the High Court of Delhi<sup>1</sup>, by which the High Court struck down proviso to Regulation 4(2)(a) of the **Medical Council of** India Regulations on Graduate Medical Education, 1997 (for short, "Regulations") as unconstitutional. By the said proviso, candidates who have passed 10+2 from open schools were not eligible to appear for National Eligibility-cum-Entrance Test (hereinafter referred to as the 'NEET').
- 4. Today, the learned counsel for the respondent showed us a letter dated 02.11.2023 addressed by Under Graduate Medical

Education Board of the National Medical Commission. The said letter is as follows:

"Subject: Equivalence to/Recognition of Bosse (Board of Open Schooling and Skill Education, Sikkim for purposes of higher Education-reg.)

- 1. I am directed to refer to your letter No. BOSSE/Recog/NMC/2023/992 dated 21<sup>st</sup> September, 2023 on the subject cited above.
- 2. In this connection, it is to convey that all open schools recognized by Central Board of Secondary Education (CBSE) and State Education Board shall be considered for recognition by National Medical Commission (NMC) for the purpose of NEET.
- 3. This issues with the approval of President (UGMEB)."
- 5. Subsequently, a Public Notice was also issued by the Under Graduate Medical Education Board of the National Medical Commission on 22.11.2023. This notice is also placed before us. The said Public Notice is as follows:

# "PUBLIC NOTICE

- 1. The Under Graduate Medical Education Board being an Autonomous Board of the National Medical Commission is issuing the present Public Notice in view of the large number of queries/representations, as well as, the various pending court cases involving the common issue as addressed herein below.
- 2. The erstwhile Medical Council of India through the provisions of the Regulations on Graduate Medical Education, 1997 including the various amendments, under Chapter-II had

regulated the admission & selection to MBBS The same included that candidates must course. undergone 2 vears of regular/ continuous/coterminous study of the subjects of Physics, Chemistry, Biology/Biotechnology, Class 11<sup>th</sup> & 12<sup>th</sup> with practical, alongwith The said 2 years study was required English. to be completed from regular schools and not from open schools or as private candidates. Further, the study of Biology/Biotechnology or any other requisite subject, could not completed additional subject as an after passing Class 12<sup>th</sup>.

- 3. The aforesaid provisions had challenged before the Hon'ble Delhi High Court quashed vide judgement and were 11.05.2018 passed in the case of Anshul Aggrawal Vs. Union of India & Ors. - W.P. (C) No. 1813 of 2018 & other connected matters and iudgement dated 17.08.2017 passed in the case of Tanishq Gangwar & Ors. Vs. Union of India & Ors.- W.P. (C) No. 6773 of 2018 & other connected matters.
- 4. The aforesaid had a consequential bearing candidates seeking admission on the Graduate/Primary Medical Courses in Foreign Medical Institutes due to the Statutory Regulations in this regard i.e. the Eligibility for admission in Requirement taking an Undergraduate Medical Course in a Foreign Medical Institution Regulations, 2002 & the Screening Test Regulation, 2002.
- 5. In the aforementioned background, candidates had been debarred from NEET-UG Test as also their applications seeking Eligibility Certificate were rejected.
- In the meanwhile, the National Medical Commission has framed the Graduate Medical Education Regulations, 2023 as notified on Regulation 11(b) provides 02.06.2023. that candidates who have passed 10+2 or its equivalent with the subjects of Physics, Chemistry, Biology/Biotechnology & **English**

shall be eligible for appearing in NEET-UG. Therefore, after the framing of Graduate Medical Education Regulation, 2023 the earlier Regulations on Graduate Medical Education, 1997 including the various amendments stand repealed prospectively.

- 7. National Medical Commission in its The 14.06.2023 after detailed meeting held on deliberations while taking into consideration the New Education Policy, which permits great extent of flexibility in the study of various subjects in Class 12<sup>th</sup>, decided that previous approach of the erstwhile Medical Council of India needs to be revisited by permitting candidates to undertake study of the subjects (Physics, requisite Chemistry, Biology/Biotechnology alongwith English) even as additional subjects after passing Class 12th from duly recognized boards by the concerned Govt. Such candidates shall be permitted to appear in NEET-UG Test and resultantly also be eligible for grant of Eligibility Certificate.
- The present decision shall be applicable 8. retrospectively also on candidates applications for of **Eligibility** grant Certificate have been rejected on the grounds contemplated in the present public notice. However, for the purpose of appearing in NEET-UG, candidates who become eligible after the date of the present public notice, shall be permitted to appear in NEET-UG-2024. Further, court cases filed by MCI/NMC, as before any in this regard Hon'ble Court, shall withdrawn and that the current position with the present public notice shall be explained in all pending litigations filed by candidates, against MCI/NMC, so that the same could be disposed at the earliest.
- 9. This issues with the approval of the competent authority."
- 6. In view of the above referred letter and Public Notice, it is clear that open schools recognized by CBSE and State

Education Boards shall be recognized by the National Medical Council for the purpose of taking the NEET Examination.

7. Taking note of the above, the Civil Appeal stands disposed of.
