UNNIKRISHNAN, SPECIAL GOVERNMENT PLEADER for R5, SRI.ANTONY MUKKATH, STANDING COUNSEL for Addl.R8, SRI.T.C.KRISHNA, SENIOR PANEL COUNSEL (DEPUTY SOLICITOR GENERAL-IN-CHARGE) for Addl.R9 & Addl.R10, SRI.K.S.PRENJITH KUMAR, Central Government Counsel for Addl. **ORDER**

**Bechu Kurian Thomas, J.**

A special Sitting of this Bench was necessitated on account of a news broadcast by the visual media about poisoning of few children at an Anganwadi at Ponnurunni in Ward No.48 of Kochi Corporation. The news visuals indicated a drainage that runs adjacent to the Anganwadi, filled with filth to the brim. It is an embarrassment for the whole city, to witness such accumulation of filth without being removed.

2. Sri.Janardhana Shenoy, the learned Standing Counsel for the Corporation submitted that Ponnurunni is one of the well maintained divisions in the Corporation and that the drainage is being attended regularly. However, they are verifying the reason for the food poisoning as well as the accumulation of filth in the drain.

3. In this context, we were also informed about the incident of

waste generated from Kerala having been dumped at Tirunelveli in Tamil Nadu. Quite often, we have been indicating to the Government the necessity of keeping track of the mode in which the waste is being disposed off by agencies who are collecting the waste. It is an alarming situation that waste generated in Kerala is disposed off in the neighbouring State, haphazardly and contrary to the legal requirements. Such instances are to be avoided.

4. In view of the above circumstances, we deem it necessary to issue the following directions :-

(i). The Secretary of the Kochi Corporation or the person in charge shall file an affidavit as to the steps being initiated to clear the filth from the drains in the Cochin city and also to prevent dumping and accumulation of plastic and other wastes into the drains, rivers and backwaters.

(ii). The Secretary of the Local Self Government shall file an affidavit regarding the agencies who have been engaged in the collection and disposal of wastes from local authorities and other bulk waste generators, including hospitals, and the steps initiated to track the mode and the manner in which such agencies dispose off the wastes so collected.

(iii). We request the *Amicus Curiae* to submit a brief report

indicating areas which require attention of the Court regarding accumulation of filth, plastic and other wastes on the drains.

The report, as mentioned above shall be filed before the next posting date.
